

1. The core agenda/commencement/resumption of commercial production was resolved by letting out on lease to M/s ASM Industries (Private) Limited, recommended by the Board of Directors, approved by the Company's members in Extraordinary General Meeting held on April 30, 2021.
2. Adverse opinion issued by the independent auditors will also be removed in coming annual audited accounts for the year ended 30 Jun, 2021.

We hereby kindly request, that the name of the Company be removed from the defaulter counter along with unfreezing suspension of trading in the shares of the Company.

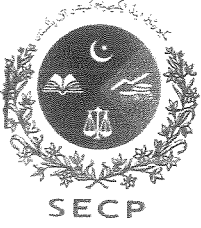
